To be eligible for the Nova Scotia Elite Sire program the applicant must:

- 1. Be a Nova Scotia based cattle producer, partnership or corporation that has a breeding herd of no less than ten cows.
- 2. Hold a 2019 Nova Scotia Cattle Grower License and have 2018 and 2017 levies paid in full by application deadline.
- 3. Agree to abide by the current Elite Sire Program Guidelines.

Payment Details

- Up to 30% of the purchase price to a maximum of \$500/animal
- Premium of \$100 for Test Station bulls with negative residual feed intake (RFI).
- Maximum of \$600/animal with base rate and premium.

Criteria for Elite Sire Purchases:

- To be considered, bulls can be no more than 2 years of age at the time of application deadline.
- Purchase date must be between January 1, 2019 and application deadline.
- Animal must be registered and ownership transfer must be updated on breed website.
- Each approved applicant farm is eligible for one bull per 30 breeding females.
- There can be no more than 2 claimed bulls per applicant.
- Breeding bulls will only be considered with a minimum of three production and/or carcass Estimated Progeny
 Difference (EPD) traits that meet or exceed the breed average.
- Qualifying bulls must be kept for a minimum of one year unless culled for disease or productivity reasons.
- Animals will only be eligible for the Nova Scotia Elite Sire Program once in their lifetime.

Note: EPDs, Ownership and Date of Birth will be collected from the Breed Website.

Criteria for Bulls on Test:

- A **test station** will be defined as any test performed at a testing facility who accepts bulls outside of their own supply and performs average daily gain and semen evaluations
- A **home test** will be defined as any test done on a farm, which accepts bulls from other herds, to measure daily weight gain that is performed on a minimum of five (5) bulls.
- The test must end between January 1, 2019 and the application deadline.
- Bulls must have a minimum on-test weight of 700 lbs.
