- 2. Hold a 2021 Nova Scotia Cattle Grower License and have 2020 and 2019 levies paid in full by application deadline.
- 3. Agree to provide copies of soil, manure and/or feed analysis as part of the application.
- 4. Agree to abide by the current NSCP Soil, Pasture and Forage Management Program Guidelines.
- **Eligible costs are only applicable for the 2021 year.
