- **2.** After the applications have been processed you will receive a letter stating the maximum amount you are approved for. **No producer will receive more than the \$4,000.00 as a combined program maximum**.
- 3. Once the equipment/sire is purchased you will have to complete the Claim form that will be included with your approval letter. Submit your Claim form, along with any and all required documents, at any time after receiving the approval letter. No claim form is necessary for bulls on test. Final deadline to have Claim submitted is Feb 28, 2017.
- **4.** A payment will be mailed out within two weeks of NSCP receiving and validating your claim form along with your receipts and documents.

To be eligible for either program the applicant must:

- 1. Hold a valid farm registration issued pursuant to the Farm Registration Act at the time of application.
- 2. Be a Nova Scotia based cattle producer, partnership or corporation that has a breeding herd of no less than five cows. This requirement may be waived for producers, partnerships or corporations registered for less than five years pursuant to the Farm Registration Act.
- 3. Be a current NSCP member at the time of application.
- 4. Be up to date with levy remittance at the time of application.
- 5. Agree to abide by the current Safe Handling of Cattle Program and/or Elite Sire Program Guidelines.

Key Points of the Safe Handling of Cattle Program:

- Headgate must include a Neck Extender. Claims for Headgates without the Neck Extender will not be paid. If you already own a Headgate and would like to just purchase a Neck Extender this will be considered for payment.
- Locking headgates will be limited to a 20 unit maximum and will only be considered for payment along with the purchase of 2 panel gates to cap off either end of the locking headgate system.
- If a commercial Crowding Tub does not fit your current farm set-up you can apply to have this program cover the gates you purchase to create your own. Only gates will be considered for payment. Costs for brackets, posts, lumber, etc. will not be approved. In addition to purchase receipts required to approve payment, a diagram of your intended tub set-up will be required to be submitted either with your application or claim form.
- Equipment must be new. Used equipment will not be covered.
- Equipment must have been purchased after April 1, 2016.

Elite Sire Program

Up to 30% of the purchase cost to a max. of \$700/animal (maximum of \$1000/animal with premiums listed below)

Premiums (on Test Station Bulls Only):

- \$100.00 for Test Station bulls having a breed Average Daily Gain (ADG) on-feed index of 100 or better (minimum of five bulls in a contemporary group of same breed on test)
- \$100.00 for Test Station bulls with a minimum of at least three breed average or above Expected Progeny Difference (EPD) on production or carcass merit traits or combination of either
- \$100.00 for Test Station bulls with negative residual feed intake (RFI)

Key Points of Elite Sire Program:

Sire Purchase

- Each approved applicant farm is eligible for one bull per 30 breeding females (or less).
- Purchase date for bulls cannot be prior to April 1, 2016.
- Breeding bulls will only be considered with a minimum of three production and/or carcass Estimated Progeny Difference (EPD) traits that meet or exceed the breed average.
- Qualifying bulls must be kept for a minimum of one year unless culled for disease or productivity reasons.

Buils on Test					
Bulls on test at a test station between June 1, 2016 – Feb 28, 2017 (maximum of \$200.00 per bull)					
Note: A test station will be defined as any test performed at a testing facility who accepts bulls outside of their own supply and performs average daily gain and semen evaluations					
Bulls on test at a home test between June 1, 2016 – Feb 28, 2017 (maximum of \$150.00 per bull)					
Note: A home test will be defined as any test done on a farm, which accepts bulls from other herds, to measure daily weight gain that is performed on a minimum of five (5) bulls. On test and off test weight will need to be submitted by the claim deadline in order to receive payment.					
Intended Testing Facility:					

Bulls sent to a test station

- Approved payments for bulls on test will be forwarded directly to the testing facility once NSCP has
 confirmed the bulls are on test no claim form will be necessary. Any overpayments to the applicant's
 account will be refunded to the applicant farm by the test station after your account has been settled.
- o Only bulls sent to a test station after June 1, 2016 will be considered.
- o Bulls must have a minimum on-test weight of 550 lbs for British breeds and 600 lbs for Continental breeds.

Maximum funding paid will be \$4,000.00 total between both programs.
